

Careful and covert surveilling (within the law) debunks any question of truth. Extant may be hired to watch someone or something, in order to prevent or detect a crime. Remote surveillance with a drone, in a technological context, is an unmanned aircraft, or aerial vehicle (UAV). There are times, when we find ourselves in rugged country terrain or areas which can not be accessed by human investigators. Remote technology then becomes the best choice.
